You should, therefore, immediately report the loss or destruction of the certificate, in form 26 which may be obtained from the officer of any Registering Authority. The report should be made to the Registering Authority with whom the vehicle is registered.
2. If the particulars on Pages 1 to 7 are not correct, you should at once take, or send, the certificate to the Registering or the Taxation Authority, as the case may be, and point out the mistakes.

Alteration of vehicle

3. You should not make any change in the Vehicle which affects the particulars contained in the Certificate of registration (especially items 1 to 18 on Pages 4 to 6) unless you have given notice, to the Registering Authority within whose jurisdiction you reside, of the

such new address, and forward the Certificate of registration to that authority, so that new address may be entered therein. This will not apply if the change is of a temporary nature not exceeding six months.

Change of ownership

5. When you transfer the vehicle to another person you should within fourteen days—

- Report the transfer in the prescribed form 29 to the Registering Authority within whose jurisdiction the transfer is effected and
- Hand over the certificate of registration and one copy of form 29 to the person to whom you have transferred the vehicle.
- In case the vehicle is the subject of an agreement of hire-purchase and such an agreement has been fulfilled get the hire-purchase agreement cancelled by applying in the prescribed form 35.
- If the agreement is to be continued in relation to the transfer, get the consent of the party to the H. P. agreement on prescribed form included in form 30.

Transfer to another State

6. When a vehicle is transferred to you by another person you must within thirty days apply to the Registering Authority within whose jurisdiction you reside or have place of business in the prescribed form 30 and forward certificate of registration, copy of form 29 given by previous owner, Certificate of insurance valid in your name from the date of purchase to that authority. (Section 50 of M. V. Act, 1988).

7. If the registered owner of the vehicle covered by the certificate no longer resides in the State in which the vehicle is re-registered, he is bound to report the matter to the Registering Authority, nearest to his place of residence or business and after residence in the new

State for 12 months he may be required to obtain and affix to the Vehicle a new registration mark (number plate).

Validity of the Certificate

8. The Certificate of Registration is valid throughout the State of India, but does not entitle the holder to use the Vehicle anywhere without payment of the tax due under the provision of any legislation in force.

9. If the vehicle to which the Certificate refers is a transport vehicle that is to say, is used for the Carriage of goods, or is a locomotive or a tractor, or is used for the Carriage of Passengers for hire or reward a permit is required under the provisions of Section 66 of the Act and the Certificate of registration is only effective so long as there is in force a certificate of fitness issued under Section 56.

Cessation of validity of the Certificate

10. If the vehicle described in the Certificate is destroyed or becomes permanently unfit for use, or is permanently removed out of India, the registered owner should return the Certificate of registration to the authority with whom the vehicle was registered. This should be done within 14 days. Failure to do so renders the owner liable to prosecution.

Special warning to drivers of transport vehicles

11. If you load the Vehicle or drive it when it is loaded in such a way that the laden weight or the axle weight of any axle, or the number of passengers being carried exceeds the laden weight, the axle weight or the number of passengers specified on Pages 4 to 6 of this book, you will be liable, upon conviction under section 194 of the Act, to fine which may extend to Rs. 2,000 in the case of the first offence and to Rs. 5,000 in the case of a second or subsequent offence.
